WE INTEND, DECLARE AND AGREE that this FULL AND FINAL RELEASE is entered into in good faith on our behalf and that in doing so, we have considered the extent of any potential damages to us in this matter.

WE INTEND, DECLARE AND AGREE that in executing this FULL AND FINAL RELEASE, we are not relying upon any statement or representation made by the parties hereby released or any of those parties' agents, servants, officials or counsel, or any other person concerning the nature, extent or duration of any occurrence, offense, or alleged injuries, damages, penalties, or concerning any other matter, but are relying solely upon our own judgment and/or the advice of our attorneys.

WE INTEND DECLARE AND FURTHER AGREE THAT we are responsible for satisfying any and all outstanding claims or liens of any type against the proceeds of the settlement, and that we and our counsel agree to indemnify and hold harmless the RELEASEES and HEYL, ROYSTER, VOELKER & ALLEN with respect to any claims or liens and all costs and expenses, including counsel's fees, in connection therewith that arises out of the facts alleged in the suit described in the first paragraph of this Release.

Attorneys' Fees, Costs and Expenses. JOHN KRAFT, KIRK ALLEN and CHRISTOPHER HANSEN and their attorneys, JOSHUA BURDAY and LOEVY & LOEVY, acknowledge that the sum of Twelve Thousand Seven Hundred Fifty Dollars (\$12,750.00) will be paid to JOHN KRAFT, KIRK ALLEN and CHRISTOPHER HANSEN, and their attorneys, and is intended to cover any and all claims, demands, causes of action, or rights of action of any kind for attorneys' fees, costs or expenses for any services rendered, or litigation costs or expenses incurred by the attorneys for JOHN KRAFT, KIRK ALLEN and CHRISTOPHER HANSEN, in the consideration, investigation, representation and prosecution of an alleged and disputed claim on behalf of JOHN KRAFT, KIRK ALLEN and CHRISTOPHER HANSEN in case number 2020-CH-000121 venued in the Sixth Judicial Circuit Court, Champaign County, Illinois.; and further, JOHN KRAFT, KIRK ALLEN and CHRISTOPHER HANSEN; JOSHUA BURDAY and LOEVY & LOEVY agree that this settlement fund will and has been received by them and that this settlement fund is in exchange for and intended to include a release and satisfaction of all claims or rights of action for attorneys' fees, costs and expenses, whether such a claim be based on statute, at law or in equity.

WE DECLARE AND AGREE that if any section or part of this Release is held to be invalid by a court of law, that the remaining portions of this Release shall continue to be and remain in full force and effect.
