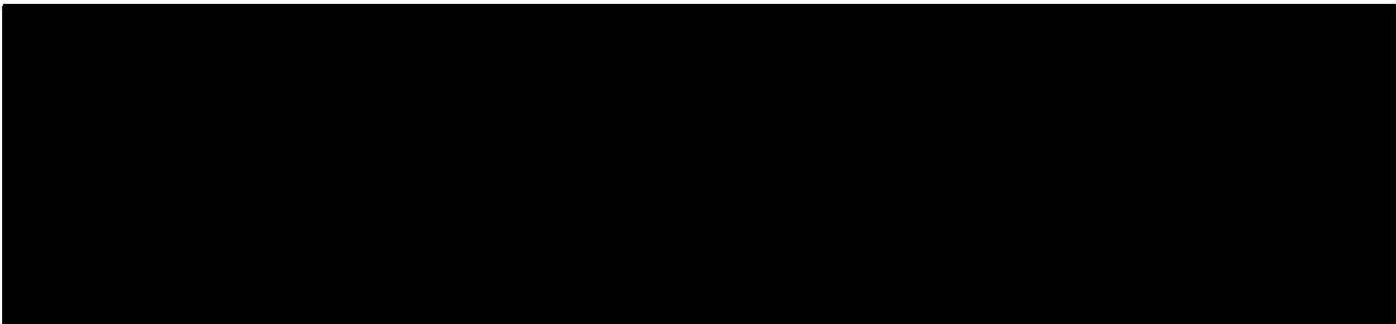

NARRATIVE

On 03/05/2022 I was working as a patrol officer for the Champaign Police Department. I was wearing a Class C uniform and driving squad #34.

At 0200 hrs I was dispatched to Red Lion (211 E Green St) to assist UIPD with a Battery.

Upon arrival UIPD advised a female, Jaelynn, had hit her head and was being transported to Carle for her injuries. See their reports for further (I20-02694).



I then watched the security footage of the incident. I observed [REDACTED] Jaelynn out of the business. As he reaches the door, Jaelyn

reaches around and punches him in the mouth. [REDACTED] then tries to grab her arms and it appears that Jaelynn starts to fall to the ground. She lands face first on to the ground. Security restrains her at that time.

I asked [REDACTED] if he wanted to press charges on Jaelynn and he advised he did not want to.

I placed a copy of the security footage into evidence. I did not attached a copy to this report due to Jorge not wanting to press charges on Jaelynn.

I then went to Carle to speak with Jaelynn. Jaelynn appeared extremely intoxicated. She could barely keep herself sitting up in bed and kept dry heaving and puking. I asked her if she was intoxicated and she said she was. She also advised she had been drinking all day. I asked her how she hit her head and she said she didn't know. I asked if she remembered punching the security guard and she said she didn't remember doing that but was very sorry if she did.

Jaelynn had one small cut on the right side of her head. The injury was photographed.

I later placed the photos of Jaelynn and [REDACTED] injuries into evidence.

I classified my in car and body worn video three years.

I have nothing further to report at this time.
