I am pleased to submit the following Appointments for your approval.

## *Interim Police Chief Richard Surles* – effective April 2, 2022 through April 1, 2024 or until filled, whichever is sooner

Richard (Rich) Surles has been with the City for 24.5 years, starting as a Police Officer and moving through the ranks as a Sergeant (2007 - 2010) and Lieutenant (2010 - 2019), before being promoted to Deputy Police Chief in 2019. He has also served as an adjunct instructor at the University of Illinois Police Training Institute. He has a bachelor degree in sociology with a concentration in criminology and a master degree in management with specialization in business value and project management, both from the University of Illinois. He has also successfully completed the Northwestern University School of Police Staff and Command.

Job Summary: The Police Chief leads the Police Department In their mission to protect life, property and the constitutional rights of all citizens within the City's jurisdiction; to serve our citizens by enforcing the law, preserving the peace, and reducing the fear of crime; and to help create a safer environment in which to live, work, and play through problem solving and collaboration with our citizens. This position Is responsible for the administration and management of the Police Department; plans, directs, coordinates, and administers police operations, support and training activities; and is responsible for ensuring compliance with applicable laws and regulations.

# *Interim Deputy Police Chief Matthew Bain* – effective April 2, 2022 through April 1, 2024 or until filled, whichever is sooner

Matthew (Matt) Bain has been with the City for more than 22 years. He started as a Police Officer, was promoted to Sergeant in 2017, and then to Lieutenant in 2019. He currently serves as Lieutenant in Support Services. Matt oversees all of the civilian staff, including all of the front desk personnel. In addition, he coordinates the department's training programs and is the administrator for the records management system. He has also served as an adjunct instructor at the University of Illinois Police Training Institute. He has a bachelor degree in criminal justice and psychology. Lt. Bain currently is attending the Northwestern University School of Police Staff and Command.

Job Summary: The Deputy Police Chief is responsible to the Chief of Police for the administration of all Police operations including enforcement of traffic laws, crime prevention, patrol and criminal investigation, administration of the records management system, animal control services, budget, and grant management. The position assists the Chief of Police in the administration of the department budget and supervises both sworn and civilian (uniform and non-uniform staff). The Deputy Police Chief reports to the Police Chief.

### **PUBLIC INPUT**

The City of Urbana welcomes Public Input during open meetings of the City Council, the City Council's Committee of the Whole, City Boards and Commissions, and other City-sponsored meetings. Our goal is to foster respect for the meeting process, and respect for all people participating as members of the public body, city staff, and the general public. The City is required to conduct all business during public meetings. The presiding officer is responsible for conducting those meetings in an orderly and efficient manner.

Public Input will be taken in the following ways:

## **Zoom Webinar Participant**

Click on the link listed in the agenda to join the Webinar. You must provide your name and email address in order to join the Webinar. If you wish to speak during Public Input, "raise your hand" and wait to be called on by the meeting host. You must state your first and last name for the meeting record. Participants will be muted except when they are called on to speak; video will remain off for all members of the public when speaking.

## **Telephone Participant**

Call the phone number listed on the Agenda. Enter the Webinar ID followed by the # key. All callers are muted by default. If you wish to speak, "raise your hand" by pressing \*9 once. When you are called on by the host or presiding officer, you will be un-muted. You must state your first name and last name for the meeting record.

## **Email Input**

Public comments must be received prior to the closing of the meeting record (at the time of adjournment unless otherwise noted) at the following: <a href="mailto:citycouncil@urbanaillinois.us">citycouncil@urbanaillinois.us</a>. The subject line of the email must include the words "PUBLIC INPUT" and the meeting date. Your email will be sent to all City Council members, the Mayor, City Administrator, and City Clerk. Emailed public comments <a href="mailto:labeled as such">labeled as such</a> will be incorporated into the public meeting record, with personal identifying information redacted. Copies of emails will be posted after the meeting minutes have been approved.

## Written Input

Any member of the public may submit their comments addressed to the members of the public body in writing. If a person wishes their written comments to be included in the record of Public Input for the meeting, the writing should so state. Written comments must be received prior to the closing of the meeting record (at the time of adjournment unless otherwise noted).

## Verbal Input

Protocol for Public Input is one of respect for the process of addressing the business of the City. Obscene or profane language, or other conduct that threatens to impede the orderly progress of the business conducted at the meeting is unacceptable.

Public comment shall be limited to no more than four (4) minutes per person. The Public Input portion of the meeting shall total no more than one (1) hour, unless otherwise shortened or extended by majority vote of the public body members present. The presiding officer or the city clerk or their designee, shall monitor each speaker's use of time and shall notify the speaker when the allotted time has expired. A person may participate and provide Public Input once during a meeting and may not cede time to another person, or split their time if Public Input is held at two

(2) or more different times during a meeting. The presiding officer may give priority to those persons who indicate they wish to speak on an agenda item upon which a vote will be taken. The presiding officer or public body members shall not enter into a dialogue with citizens. Questions from the public body members shall be for clarification purposes only. Public Input shall not be used as a time for problem solving or reacting to comments made but, rather, for hearing citizens for informational purposes only.

In order to maintain the efficient and orderly conduct and progress of the public meeting, the presiding officer of the meeting shall have the authority to raise a point of order and provide a verbal warning to a speaker who engages in the conduct or behavior proscribed under "Verbal Input". Any member of the public body participating in the meeting may also raise a point of order with the presiding officer and request that they provide a verbal warning to a speaker. If the speaker refuses to cease such conduct or behavior after being warned by the presiding officer, the presiding officer shall have the authority to mute the speaker's microphone and/or video presence at the meeting. The presiding officer will inform the speaker that they may send the remainder of their remarks via e-mail to the public body for inclusion in the meeting record.
