NARRATIVE											

On 3/5/22 at 0147 hrs, I (Ofc Benjamin Crane) along with Ofc Kennedy Hartman were sitting in our squad car outside of Red Lion bar (211 E Green St). I was observing bar close and watching patrons exit the bar. Multiple officers from UIPD and CPD later backed the call. I reviewed my in car camera before writing this report with the permission of my supervisor.

I noticed that Red Lion security [REDACTED] was escorting a female (Jaelynn Edwards) out of the bar and she appeared intoxicated and disorderly as she was resisting their escort. Once outside the bar I witnessed Edwards turn around the punch Vasquez in the mouth with a closed fist. [REDACTED] sustained a laceration to his lower lip that required medical attention (stitches). After [REDACTED] was struck he took Edwards to the ground rapidly.

Ofc Hartman and I quickly exited our vehicle to stop any further altercation. When I approached Edwards, I noticed that she was barely conscious, and that she sustained multiple lacerations to her head. It appeared that one laceration was from her head striking the wall and the second was a laceration cause by the impact with the ground. Edwards lost consciousness and I radioed for expedited EMS assistance due to visible blood and unresponsiveness. Ofc Hartman was able to determine that Edwards was still breathing.

A short time later additional UIPD officers arrived on scene with medical

supplies to help control any further bleeding. Champaign Fire and EMS arrived on scene and took over triage of Edwards. Edwards was ultimately placed in an AMT ambulance and transported to Carle Hospital. CPD responded and watched the outside surveillance footage of the altercation.

I interviewed Edwards' friend, Christian Struessel. Struessel was behind the security guard as Edwards was being escorted from the bar and only saw [REDACTED] take Edwards to the ground. Struessel appeared highly intoxicated and admitted that he never saw Edwards strike [REDACTED]. Struessel was extremely upset that [REDACTED] injured Edwards. Struessel said that Edwards was not a UIUC student and that he thought she currently lived in [REDACTED] even though her identification card was out of [REDACTED].

I cleared the scene at 0218 hrs. I later submitted my body worn camera and my in car video, which captured the initial altercation, to the UIPD evidence O: drive.
