### **COMPLAINT**

NOW COMES Plaintiff, CHRISTOPHER HANSEN, by the undersigned attorneys, Loevy & Loevy, and brings this suit to overturn Defendants' willful violation of the Illinois Freedom of Information Act. HANSEN has requested various records pertaining to potential police misconduct. HANSEN attempted to resolve the matter without litigation by repeatedly providing his news media credentials to CHAMPAIGN COUNTY STATE'S ATTORNEY'S OFFICE, but Defendant has continued to assess burdensome fees that the statute does not allow to be charged to media requesters and has denied HANSEN's FOIA request. CITY OF URBANA and VILLAGE OF RANTOUL, in a similar manner, identified HANSEN as a "recurrent requester" and have delayed the release of records even though he explicitly made the request as a member of the news media and provided his news media credentials. Since as early as October 2020, HANSEN repeatedly stated that he is a member of the news media, but Defendants have continuously ignored his good faith attempts, which left him no choice but to bring forth litigation regarding this matter. In support of the Complaint, HANSEN states as follows:

#### INTRODUCTION

- 1. Pursuant to the fundamental philosophy of the American constitutional form of government, it is the public policy of the State of Illinois that all persons are entitled to full and complete information regarding the affairs of government and the official acts and policies of those who represent them as public officials and public employees consistent with the terms of the Illinois Freedom of Information Act ("FOIA"). 5 ILCS 140/1.
- 2. Restraints on access to information, to the extent permitted by FOIA, are limited exceptions to the principle that the people of this state have a right to full disclosure of information relating to the decisions, policies, procedures, rules, standards, and other aspects of government activity that affect the conduct of government and the lives of the people. 5 ILCS 140/1.
- 3. Under FOIA Section 1.2, "[a]ll records in the custody or possession of a public body are presumed to be open to inspection or copying. Any public body that asserts that a record is exempt from disclosure has the burden of proving by clear and convincing evidence that it is exempt." 5 ILCS 140/1.2.

#### **PARTIES**

- 4. Plaintiff CHRISTOPHER HANSEN made the FOIA request at issue in this case. HANSEN is the founder of Check CU, which is a news-media website. *See* https://checkcu.org/about.
- 5. Defendant CHAMPAIGN COUNTY STATE'S ATTORNEY'S OFFICE ("CHAMPAIGN COUNTY SAO") is a public body located in Champaign County, IL.
- 6. Defendant CITY OF URBANA ("URBANA") is a public body located in Champaign County, IL.
- 7. Defendant VILLAGE OF RANTOUL ("RANTOUL") is a public body located in Champaign County, IL.

### **DECEMBER 17, 2020 FOIA REQUEST TO CHAMPAIGN COUNTY SAO**

- 8. On December 17, 2020, HANSEN submitted a FOIA request to CHAMPAIGN COUNTY SAO for "[a]ny and all records related to the arrest, jailing, and prosecution of Quintin Brown and Wayne Colson." HANSEN specified that he seeks "all reports, police reports, dash cam video, body cam video, jail video, emails, electronic messages, etc." about these two individuals. Ex. 1.
- 9. Quintin Brown and Wayne Colson were arrested in February 2018 and held in jail for a year for crimes they did not commit. The CHAMPAIGN SAO dismissed the cases against Mr. Brown and Mr. Colson on January 22, 2019. Mr. Brown and Mr. Colson recently each filed a civil lawsuit alleging that the police officers fabricated eyewitness identifications to procure the arrest warrants.
- 10. On December 21, 2020, CHAMPAIGN COUNTY SAO asserted that HANSEN does not "fit the applicable legal definition(s) of 'news media'" and therefore HANSEN must pay fees for CHAMPAIGN SAO to process the request. Ex. 2.
- 11. Prior to the December 17, 2020 request, HANSEN had submitted an identical request to CHAMPAIGN COUNTY SAO on June 8, 2020, September 25, 2020, and October 26, 2020. In response to each request, CHAMPAIGN COUNTY SAO refused to identify HANSEN as a news media requester, categorized the request as "voluminous," and assessed \$200 for fees even though HANSEN explicitly stated that he is the member of the news media. Group Exhibit 3.
- 12. CHAMPAIGN COUNTY SAO referenced its prior denial letters in its response to HANSEN's December 17, 2020, request. Ex. 2.

- 13. Section 2(f) of FOIA defines "news media" as "a newspaper or other periodical issued at regular intervals whether in print or electronic format, a news service whether in print or electronic format, a radio station, a television station, a television network, a community antenna television service, or a person or corporation engaged in making news reels or other motion picture news for public showing." 5 ILCS 140/2(f).
- 14. Section 2(h) of FOIA states, in relevant part, "Voluminous request' does not include a request made by news media and non-profit, scientific, or academic organizations if the principal purpose of the request is: (1) to access and disseminate information concerning news and current or passing events; (2) for articles of opinion or features of interest to the public; or (3) for the purpose of academic, scientific, or public research or education." 5 ILCS 140/2(h).
  - 15. Section 6 (a) and (d) state:
  - (a) When a person requests a copy of a record maintained in an electronic format, the public body shall furnish it in the electronic format specified by the requester, if feasible. If it is not feasible to furnish the public records in the specified electronic format, then the public body shall furnish it in the format in which it is maintained by the public body, or in paper format at the option of the requester. A public body may charge the requester for the actual cost of purchasing the recording medium, whether disc, diskette, tape, or other medium. If a request is not a request for a commercial purpose or a voluminous request, a public body may not charge the requester for the costs of any search for and review of the records or other personnel costs associated with reproducing the records. Except to the extent that the General Assembly expressly provides, statutory fees applicable to copies of public records when furnished in a paper format shall not be applicable to those records when furnished in an electronic format.
  - (d) The imposition of a fee not consistent with subsections 6(a) and (b) of this Act constitutes a denial of access to public records for the purposes of judicial review.
- 5 ILCS 140/6(a), (d). (Emphasis added).
  - 16. HANSEN meets the definition of "news media" under Section 2(f) of FOIA.
- 17. HANSEN has founded and operates the non-profit news website, Check CU. *See* https://checkcu.org.

- 18. Around the time of CHAMPAIGN COUNTY SAO's December 21, 2020 denial, HANSEN's news website Check CU had more than 70 articles published and about 35 separate entries in the Records Library, where he shares government records obtained via FOIA with the general public.
- 19. In addition, HANSEN's articles were published in *Public i*, a non-profit newspaper in Urbana Champaign that is operated by the Urbana-Champaign Independent Media Center. *See* http://publici.ucimc.org/about.
- 20. Further, HANSEN is a member of the Investigative Journalists and Editors ("IRE") and the Society of Professional Journalists ("SPJ").
- 21. Pursuant to Section 2(h) of FOIA, HANSEN's request is not a "voluminous request" as it is a request made by news media.
- 22. Because HANSEN is a member of the news media, pursuant to Section 6(d) of FOIA, CHAMPAIGN COUNTY SAO's imposition of a fee that is not consistent with Section 6(a) of FOIA constitutes as a denial of HANSEN's request.
- 23. HANSEN has repeatedly provided his news media credentials to CHAMPAIGN COUNTY SAO. Ex. 1; Ex. 3 at 4, 10, and 17.
- 24. Despite HANSEN's repeated attempts to establish his news media status to avoid litigation, CHAMPAIGN COUNTY SAO has refused to acknowledge HANSEN as a member of the news media, has categorized his FOIA request as "voluminous," and has denied his request by imposing a non-statutory fee.
- 25. As of the date of this filing, CHAMPAIGN COUNTY SAO has failed to comply with FOIA and has produced no records responsive to the request.

### MARCH 15, 2022 FOIA REQUEST TO URBANA

- 26. On March 15, 2022, HANSEN submitted a FOIA request to URBANA for "[a]ny and all records relate to the 2018 arrests of Quintin Brown and Wayne Colson, and the resulting criminal cases 2018CF000107 and 2018CF000108." HANSEN specified that the records should include "all documents, video and audio files, and related correspondence." Ex. 4.
- 27. On March 21, 2022, URBANA stated that it is "treating" HANSEN's request as a "request from a recurrent requester, as defined in Section 2(g)" of FOIA. Ex. 5.
- 28. On March 21, 2022, HANSEN informed URBANA that he is making the request as a member of the news media. HANSEN asked if URBANA needs additional information beyond the credentials that HANSEN provided in his original request, but URBANA never responded. Ex. 6.
- 29. Section 2(g) of FOIA states, in relevant part, "For purposes of this definition, requests made by news media and non-profit, scientific, or academic organizations shall not be considered in calculating the number of requests made in the time periods in this definition when the principal purpose of the requests is (i) to access and disseminate information concerning news and current or passing events, (ii) for articles of opinion or features of interest to the public, or (iii) for the purpose of academic scientific, or public research or education." 5 ILCS 140/2(g). (Emphasis added).
- 30. HANSEN has been stating that he is a member of the news media in his FOIA requests since October 23, 2020.
- 31. HANSEN's March 15, 2022 request included his credentials, such as links to his website CheckCU and the YouTube page associated with CheckCU, as well as other news outlets where his articles were published. Ex. 4.

- 32. As previously stated, HANSEN meets the definition of "news media" under Section 2(f) of FOIA.
- 33. HANSEN made the above request as a member of the news media and to disseminate information regarding the arrest of Mr. Colson and Mr. Brown.
- 34. Further, because HANSEN is a member of the news media, under Section 2(g) of FOIA his requests should not be considered in calculating the number of requests to categorize him as a "recurrent requester."
  - 35. URBANA's deadline to comply with the request was March 23, 2022.
- 36. Even though HANSEN offered to provide additional information to URBANA to establish his news media credentials to avoid litigation, URBANA has ignored his attempt and has denied the request by failing to comply with the request within the statutory deadline.
- 37. As of the date of this filing, URBANA has failed to comply with FOIA and has produced no records responsive to the request.

#### MARCH 24, 2022 FOIA REQUEST TO RANTOUL

- 38. On March 24, 2022, HANSEN submitted a FOIA request to RANTOUL for "[a]ll police reports, video, and images related to an incident that occurred on or around August 4, 2015 regarding an armed robbery and eventual officer involved shooting in Rantoul." To aid RANTOUL's search for records, HANSEN provided a link to a news article that discusses the incident. Ex. 7.
  - 39. On April 2, 2022, RANTOUL acknowledged receipt of the request. Ex. 8.
- 40. On April 2, 2022, RANTOUL stated that it is "treating" HANSEN as a recurrent requester "under subsection (g) of Section 2" of FOIA. Ex. 9.

- 41. On April 2, 2022, HANSEN reiterated that he is making this request as a member of the news media and cannot treat the request as a request from a recurrent requester, but RANTOUL never responded. Ex. 10.
- 42. HANSEN's March 24, 2022 request included his credentials, such as links to his website CheckCU and the YouTube page associated with CheckCU, as well as other news outlets where his articles were published. Ex. 7.
- 43. HANSEN has been stating that he is a member of the news media in his FOIA requests since October 29, 2021.
- 44. As previously stated, HANSEN meets the definition of "news media" under Section 2(f) of FOIA.
- 45. HANSEN made the above request as a member of the news media and to disseminate information about an officer-involved shooting.
- 46. Further, because HANSEN is a member of the news media, under Section 2(g) of FOIA his requests should not be considered in calculating the number of requests to categorize him as a "recurrent requester."
  - 47. RANTOUL's deadline to comply with the request was April 1, 2022.
- 48. Even though HANSEN provided information to RANTOUL to establish his news media credentials and ultimately to avoid litigation, RANTOUL has ignored his attempt and has denied the request by failing to comply with the request within the statutory deadline.
- 49. As of the date of this filing, RANTOUL has failed to comply with FOIA and has produced no records responsive to the request.

### COUNT I – DECEMBER 17, 2020 FOIA REQUEST TO CHAMPAIGN COUNTY SAO, FAILURE TO PRODUCE RECORDS

50. The above paragraphs are incorporated by reference.

- 51. CHAMPAIGN COUNTY SAO is a public body under FOIA.
- 52. The records sought in the FOIA request are non-exempt public records of CHAMPAIGN COUNTY SAO.
- 53. CHAMPAIGN COUNTY SAO violated FOIA by failing to provide records responsive to the request.

### COUNT II – DECEMBER 17, 2020 FOIA REQUEST TO CHAMPAIGN COUNTY SAO, FAILURE TO PERFORM AN ADEQUATE SEARCH

- 54. The above paragraphs are incorporated by reference.
- 55. CHAMPAIGN COUNTY SAO is a public body under FOIA.
- 56. CHAMPAIGN COUNTY SAO bears the burden of proving beyond material doubt that it performed an adequate search for records responsive to the request.
- 57. CHAMPAIGN COUNTY SAO has failed to come forward with sufficient evidence to carry this burden.
- 58. CHAMPAIGN COUNTY SAO has violated FOIA by failing to adequately search for records responsive to the request.

### COUNT III – DECEMBER 17, 2020 FOIA REQUEST TO CHAMPAIGN COUNTY SAO WILLFUL AND INTENTIONAL VIOLATION OF FOIA

- 59. The above paragraphs are incorporated by reference.
- 60. CHAMPAIGN COUNTY SAO is a public body under FOIA.
- 61. The records sought in the FOIA request are non-exempt public records of CHAMPAIGN COUNTY SAO.
- 62. During the time period of December 17, 2020, to present, CHAMPAIGN COUNTY SAO was aware of the definition of "news media" under Section 2(f) of FOIA.

- 63. During the time period of December 17, 2020, to present, CHAMPAIGN COUNTY SAO was aware that "voluminous requests" do not include requests made by news media pursuant to Section 2(h) of FOIA.
- 64. During the time period of December 17, 2020, to present, CHAMPAIGN COUNTY SAO was aware that HANSEN has provided his news media credentials in his December 17, 2020 request and his prior requests.
- 65. During the time period of December 17, 2020, to present, CHAMPAIGN COUNTY SAO was aware that HANSEN has founded and operates the news website, Check CU.
- 66. During the time period of December 17, 2020, to present, CHAMPAIGN COUNTY SAO was aware that HANSEN meets the definition of "news media" under Section 2(f) of FOIA.
- 67. During the time period of December 17, 2020, to present, CHAMPAIGN COUNTY SAO was aware that imposing a fee that is not consistent with Section 6(a) of FOIA constitutes a denial of access to public records under Section 6(d) of FOIA.
- 68. Because CHAMPAIGN COUNTY SAO had no good faith basis to deny HANSEN's status as a member of the news media, to identify the FOIA request as a voluminous request, to assess fees inconsistent with Section 6(a) of FOIA, and to deny the FOIA request, CHAMPAIGN COUNTY SAO has willfully and intentionally or otherwise in bad faith violated FOIA.

### COUNT IV – MARCH 15, 2022 FOIA REQUEST TO URBANA, FAILURE TO PRODUCE RECORDS

- 69. The above paragraphs are incorporated by reference.
- 70. URBANA is a public body under FOIA.

- 71. The records sought in the FOIA request are non-exempt public records of URBANA.
  - 72. URBANA violated FOIA by failing to provide records responsive to the request.

## COUNT V – MARCH 15, 2022 FOIA REQUEST TO URBANA, FAILURE TO PERFORM AN ADEQUATE SEARCH

- 73. The above paragraphs are incorporated by reference.
- 74. URBANA is a public body under FOIA.
- 75. URBANA bears the burden of proving beyond material doubt that it performed an adequate search for records responsive to the request.
  - 76. URBANA has failed to come forward with sufficient evidence to carry this burden.
- 77. URBANA has violated FOIA by failing to adequately search for records responsive to the request.

## COUNT VI – MARCH 15, 2022 FOIA REQUEST TO URBANA, WILLFUL AND INTENTIONAL VIOLATION OF FOIA

- 78. The above paragraphs are incorporated by reference.
- 79. URBANA is a public body under FOIA.
- 80. The records sought in the FOIA request are non-exempt public records of URBANA.
  - 81. URBANA is aware of the definition of "news media" under Section 2(f) of FOIA.
- 82. During the time period of March 15, 2022, to present, URBANA was aware that requests made by news media shall not be considered in calculating the number of requests to determine whether the request is a "recurrent requester" under Section 2(g) of FOIA.
- 83. During the time period of March 15, 2022, to present, URBANA was aware that HANSEN has provided his news media credentials in his March 15, 2022 request and his prior requests.

- 84. During the time period of March 15, 2022, to present, URBANA was aware that HANSEN has founded and operates the news website, Check CU.
- 85. During the time period of March 15, 2022, to present, URBANA was aware that HANSEN meets the definition of "news media" under Section 2(f) of FOIA.
- 86. Because URBANA had no good faith basis to identify HANSEN as a "recurrent requester" and to deny the FOIA request by failing to comply with the request, URBANA has willfully and intentionally or otherwise in bad faith violated FOIA.

### MARCH 24, 2022 FOIA REQUEST TO RANTOUL, FAILURE TO PRODUCE RECORDS

- 87. The above paragraphs are incorporated by reference.
- 88. RANTOUL is a public body under FOIA.
- 89. The records sought in the FOIA request are non-exempt public records of RANTOUL.
  - 90. RANTOUL violated FOIA by failing to provide records responsive to the request

## MARCH 24, 2022 FOIA REQUEST TO RANTOUL, FAILURE TO PERFORM AN ADEQUATE SEARCH

- 91. The above paragraphs are incorporated by reference.
- 92. RANTOUL is a public body under FOIA.
- 93. RANTOUL bears the burden of proving beyond material doubt that it performed an adequate search for records responsive to the request.
- 94. RANTOUL has failed to come forward with sufficient evidence to carry this burden.
- 95. RANTOUL has violated FOIA by failing to adequately search for records responsive to the request.

### MARCH 24, 2022 FOIA REQUEST TO RANTOUL, WILLFUL AND INTENTIONAL VIOLATION OF FOIA

- 96. The above paragraphs are incorporated by reference.
- 97. RANTOUL is a public body under FOIA.
- 98. The records sought in the FOIA request are non-exempt public records of RANTOUL.
  - 99. RANTOUL is aware of the definition of "news media" under Section 2(f) of FOIA.
- 100. During the time period of March 24, 2022, to present, RANTOUL was aware that requests made by news media shall not be considered in calculating the number of requests to determine whether the request is a "recurrent requester" under Section 2(g) of FOIA.
- 101. During the time period of March 24, 2022, to present, RANTOUL was aware that HANSEN has provided his news media credentials in his March 24, 2022 request and his prior requests.
- 102. During the time period of March 24, 2022, to present, RANTOUL was aware that HANSEN has founded and operates the news website, Check CU.
- 103. During the time period of March 24, 2022, to present, RANTOUL was aware that HANSEN meets the definition of "news media" under Section 2(f) of FOIA.
- 104. Because RANTOUL had no good faith basis to identify HANSEN as a "recurrent requester" and to deny the FOIA request by failing to comply with the request, RANTOUL has willfully and intentionally or otherwise in bad faith violated FOIA.

#### WHEREFORE, HANSEN asks that the Court:

- i. declare that Defendants have violated FOIA;
- ii. declare that Plaintiff qualifies as a member of the news media for FOIA purposes;
- iii. order Defendants to conduct an adequate search for the requested records;

- iv. order Defendants to produce the requested records;
- v. enjoin Defendants from withholding non-exempt public records under FOIA;
- vi. order Defendants to pay civil penalties;
- vii. award HANSEN reasonable attorneys' fees and costs;
- viii. award such other relief the Court considers appropriate.

### Re: FOIA Request reiterated most recently on December 17th, 2020

Dear Mr. Christopher Hansen,

The Champaign County State's Attorney's Office is in receipt of your (reiterated) request for information pursuant to the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq. (the Act), received originally on June 8<sup>th</sup>, 2020, repeated on September 25<sup>th</sup>, 2020, repeated again on October 26<sup>th</sup>, 2020, and repeated again on December 17<sup>th</sup>, 2020. This letter follows our previous correspondence - see all previous correspondence.

In our third-to-last letter to you dated September 29<sup>th</sup>, 2020, we declined your request for a fee waiver and noted that FOIA fees remain applicable to your request. In our last two letters to you dated October 15<sup>th</sup> and October 27<sup>th</sup>, 2020, we reiterated the position. See all previous correspondence.

In your most recent email, sent December 17<sup>th</sup>, 2020, at 4:03 a.m., you wrote in part: "I am writing to again ask that you comply with the FOIA and provide the requested information." You then proceed to make additional representations regarding your writing.

In response to your comment about complying with FOIA: our office is currently and has been complying with FOIA. The only impasse, if any, is that you continue to request and expect either a total fee waiver or an exemption from the fee applicable to this voluminous request. If you choose not to pay the applicable fee, that is your choice, but the applicability of the fee under FOIA has been laid out in detail in our correspondence.

The Champaign County State's Attorney's Office is in receipt of your request for information pursuant to the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq. (the Act) dated June 8, 2020 and received by our office June 8, 2020. This letter follows our previous correspondence – see all previous correspondence.

Thank you for your reply email dated June 15, 2020. You wrote "I am surprised that this request should require significant work on your end, as I'd expected other members of the public and/or parties involved in a lawsuit would have already asked for these records."

The calculation of fees for voluminous requests is addressed in the FOIA statute at 5 ILCS 140/6(a-5), and said calculations are based on the size of the responsive data (in megabytes). Personnel hours spent do not contribute to the calculation of the fee for non-commercial voluminous requests such as this one. Your FOIA request per your email dated 6/8/20 was in broad terms and requested "any and all records" across several categories in two felony cases, calling for what amount to thousands of pages across multiple records, and it is the total volume of the requested records which triggers and calculates the fee. Also, please bear in mind that the processing and tendering of materials via discovery in criminal and civil cases is very different in both law and process from the processing and tendering of materials under FOIA.

You wrote: "Are there portions that have already been prepared and distributed which you can more readily supply?"

As I mentioned above, the fee calculation is based on the volume of the responsive data. If you do choose to amend your request, how you choose to amend your request is up to you, since you would know which materials are most important to your interest and your inquiry. Both felony files you've requested information about are very large, so even an amended request for "all police reports" related to just one CF case file would still be more than 500 pages and would span multiple requested records responsive to that category. If you choose to amend your request, we will of course re-examine the

volume of records which are responsive to the request as amended and re-calculate accordingly.

You wrote: "My interest in these records, as you may have guessed, is related to the handling of these cases by the police and the justice system. The public interest is incredibly strong. I intend to distribute the records to local justice groups of which I am a part, and I will also likely write one or more articles for the Public i. I have no commercial use for the records and my interest is in distributing the records to local non-profit organizations, and for writing my own articles and engaging in my own reform work with local groups and governments. I believe the Illinois FOIA law provides exemptions for my cause in which the public body may not invoke voluminous request charges. In any case, I politely request a fee waiver for my purposes."

Thank you for your response and for elaborating, but some additional specific information is necessary in order to clarify your representations and properly apply the applicable provisions and definitions of FOIA:

Are you making this request as a staff member of the Public i, or other news media? The definition of "news media" as relevant to FOIA is provided at 5 ILCS 140/2(f). If so, please let us know specifically which news media organization and provide some information or means of corroborating said membership.

Alternatively, are you making this request as a staff member of a specific non-profit organization? If so, please let us know which specific non-profit organization and provide some information or means of corroborating said membership.

Once you respond, we will hopefully have enough information to properly evaluate whether your request is completely exempted from fees under FOIA, or, if not, whether it is then a matter of evaluating your request for a fee waiver or reduction.

Dear Mr. Hansen:

On March 24, 2022, you submitted a Freedom of Information Act (the Act) request by e-mail to Janet Gray, the Village Clerk for the Village of Rantoul. Your request has been forwarded to me, one of its Attorneys, to provide the response.

The request submitted was: "All police reports, video, and images related to an incident that occurred on or around August 4th, 2015 regarding an armed robbery and eventual officer involved shooting in Rantoul."

Section 2(g) of the Act defines "Recurrent requester" as a person that, in the 12 months immediately preceding the request, has submitted to the same public body (i) a minimum of 50 requests for records, (ii) a minimum of 15 requests for records within a 30-day period, or (iii) a minimum of 7 requests for records within a 7-day period. In the twelve months preceding this request, you have submitted 7 requests within a 7-day period, being one request on November 3, 2021, four requests on November 7, 2021 and three requests on November 8, 2021. As such, you fall under the definition of recurrent requester as set forth in the Act.

The Village is treating your request of March 24, 2022 as a request under subsection (g) of Section 2 of the Act. The reasons for which the Village is treating this request as one under subsection (g) of Section 2 of the Act are identified above. Pursuant to Section 3.2 of the Act, the Village's initial response will be provided within 21 business days of March 24, 2022. The proposed responses that can be asserted are: providing an estimate of the time required by the Village to provide the records requested and an estimate of the fees to be charged, if any, and which would need
