NARRATIVE

On February 7, 2023, at approximately 12:00 am, I received a phone call, while off duty from Deputy Chief Bouse. DC Bouse reported being contacted by Sgt. King, who is the shift supervisor concerning an officer-involved shooting. DC Bouse further reported the suspect in this incident had possibly sustained a self-inflicted gunshot wound that was considered to be a serious injury.

DC Bouse indicated our department would be requesting the assistance of the Champaign County Multi-Jurisdictional Investigative Team (CCMJIT) to assist the Illinois State Police in the investigation of this incident. DC Bouse also requested that our department's investigation division be

notified and instructed to respond to the Rantoul Police Department. I made phone contact with Detective Barnett and asked him to respond to the Rantoul Police Department, Detective Bross was also contacted by DC Bouse and asked to respond as well.

When I arrived, I first met with LT. Apperson from the Champaign County Sheriff's Office. LT. Apperson was escorted to the upper level of the Rantoul Fire Department, main station located at 101 E. Grove Avenue. This would become the area where investigators from the CCMJIT would meet and begin their investigation.

Body-worn cameras from officers Aceves, McComas, Mennenga, and Sgt. King was uploaded to Evidence.com. At approximately 1:15 am, I downloaded body camera footage from Officer Aceves's body-worn camera. This recording was placed onto a DVD and provided to Trooper Carr. At approximately 1:40 am, I downloaded body-worn camera footage from Officer McComas's body-worn camera. This recording was placed onto a DVD and provided to Trooper Carr. At approximately 2:40 am, I downloaded body camera footage from Sgt. King's body-worn camera. This recording was placed onto a DVD and provided to Trooper Carr. Sgt. King had also obtained six (6) digital images, at approximately 3:10 am, these images were also downloaded to DVD and provided to Trooper Carr. At approximately 4:26 am, I downloaded body camera footage from Officer Mennenga's body-worn camera. This recording was placed onto DVD and provided to trooper Carr as well.
