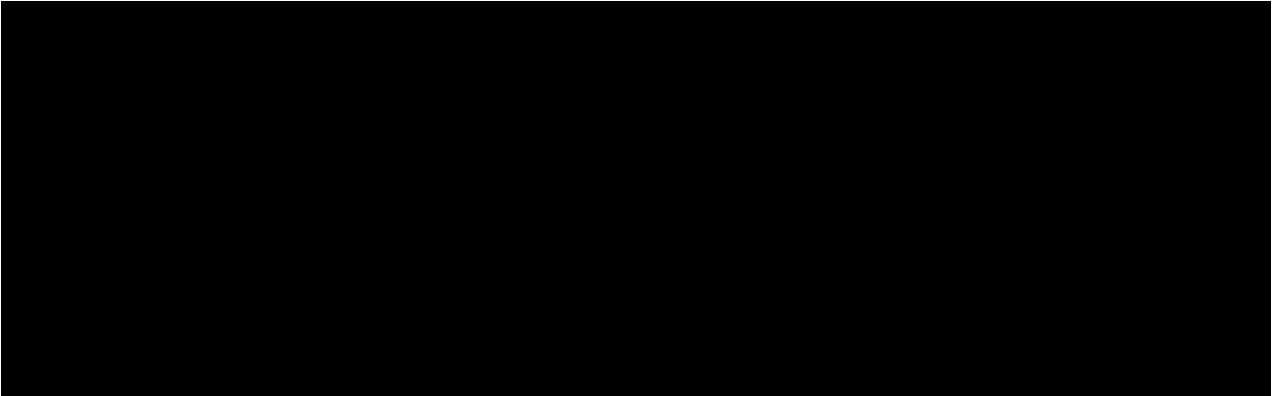

A Regular Meeting of the Board of Trustees of the Village of Rantoul was held virtually at 6:00 P.M., President Charles Smith presiding. President Smith called the meeting to order.

**Invocation & Pledge of Allegiance**

Trustee Wilkerson opened the meeting with prayer. Following the invocation, Trustee Hall led the audience in recitation of the Pledge of Allegiance.

**Roll Call**

The Clerk called the roll, finding the following members present:

Mayor Smith, Trustees Crider, Wilkerson, Hall, Robertson, Weathersby and Johnson - 7

The following representatives of Village departments were also present:

Scott Eisenhauer, Administrator; Jolene Gensler, Comptroller; Justin Bouse, Police Department; Luke Humphrey, Recreation Director; Jake McCoy, Assistant Public Works Director; David Wesner, Attorney; Ken Beth, Attorney and Janet Gray, Village Clerk.

**Approval of Agenda**

Trustee Hall moved to approve the agenda for the meeting, as presented.

Trustee Robertson seconded the motion. On a Roll Call vote:

YEAS: Hall, Robertson, Weathersby, Johnson, Crider and Wilkerson – 6.

NAYS: None – 0.

The motion carried 6-0.

**Public Participation**

Brad Gould spoke about gunfire and fireworks and his concerns for how these affect local veterans. There were shots fired in front of his house in May and neighbors started setting off fireworks in May. He reported his concerns to the Police Department and contacted the Mayor's office. Mr. Gould wanted to know what the Village is going to do about these issues?

Debbra Sweat had several items to address.

1. Ms. Sweat requested that Discretionary funds be given to each District Trustee for neighborhood services initiatives such as those outlined in the Neighborhood Services Program the Village had about four years ago. This goes along with her request to review the duties of the Trustees, to include such initiatives.
2. Ms. Sweat requested the Village revisit the decision not to allow a Marijuana dispensary in Rantoul.
3. Previously Ms. Sweat asked the board to consider moving the Community Development Block Grants funds to the Community Plus Credit Union. She asked if there had been any discussion on this request.
4. Her last request was to ask the Mayor to appoint Cynthia Rouse to the Micro Loan Committee. She stated there is no racial diversity on the committee.

Trustee Crider moved to authorize the Mayor to sign a letter by the Champaign County First Group to encourage the Federal Government to increase Amtrak service from Champaign to Chicago, which includes a stop in Rantoul. Trustee Hall seconded the motion. On a Roll Call vote:
