#### VERIFIED OBJECTOR'S PETITION

Wayne T. Williams, Jr., hereinafter referred to as the "Objector", states as follows:

- 1. Objector Wayne T. Williams, Jr. resides at 1905 North Cunningham Avenue, Apartment 208B, Urbana, Illinois, 61802, and is a duly qualified, legal and registered voter at that address in the Ward 5 of the City of Urbana, Illinois.
- 2. The City of Urbana, Illinois shall hold a partisan primary for the election of the office of Alderman of the 5<sup>th</sup> Ward of the City of Urbana on February 23, 2021.
- 3. The Objector's interest in filing this Petition is that of a voter desirous that the laws governing the filing of nomination papers for the office of Alderman of the 5<sup>th</sup> Ward of the City of Urbana, Illinois are properly complied with, and that only qualified candidates appear on the ballot for said office.
- 4. The Objector makes the following objections to the nomination papers (herein referred to as the "Nomination Papers") of Meghan McDonald (hereinafter referred to as "Respondent-Candidate") as a candidate of the Democratic Party for the nomination for the office of Alderman of the 5<sup>th</sup> Ward of the City of Urbana, Illinois, to be voted for at the

Consolidated Primary Election on February 23, 2021. The Objector states that the Nomination Papers are insufficient in fact and law for the reasons stated below.

- 5. A copy of the Respondent-Candidate's Nomination Papers is attached hereto as Exhibit A.
- 6. At the Consolidated Primary Election on February 23, 2021, the Democratic Party will make nominations for the office of Alderman in seven different Wards in the City of Urbana, Illinois.
- 7. Section 7-10 of the Illinois Election Code, 10 ILCS 5/7-10, governs the form and content of nominating petitions for candidates seeking the nomination of the Democratic Party for the office of Alderman of the 5<sup>th</sup> Ward of the City of Urbana, Illinois in the Consolidated Primary Election on February 23, 2021. Pursuant to Section 7-10, the name of no candidate for nomination shall be printed upon the primary ballot unless a petition for nomination has been filed in their behalf as provided in Section 7-10. The Nomination Papers filed by Respondent-Candidate do not comply with the requirements set forth in Section 7-10 for the following reasons:
  - a. The Respondent-Candidate's Nomination Papers fail to comply with the requirements set forth in Section 7-10, as the petition sheets fail to specify the office for which the Respondent-Candidate is seeking the nomination of the Democratic Party for at the Consolidated Primary Election on February 23, 2021.
    (see Exhibit A, pages 4-14). These sheets violate the requirements of Section 7-10 and therefore should be stricken.
  - b. The petition sheets contained in Respondent-Candidate's Nomination Papers that are numbered 1-4 and 6-11, fail to comply with the requirement set forth in

- Section 7-10 that gives information as to the office sought by Respondent-Candidate. (see Exhibit A, pages 4-7, 9-14). Each of these sheets only lists "Alderman" but fails to specify which Aldermanic District the Respondent-Candidate seeks nomination in.
- c. The petition sheets contained in Respondent-Candidate's Nomination Papers that are numbered 1-4 and 6-11, fail to comply with the requirement set forth in Section 7-10 that gives information as to the office sought by Respondent-Candidate. (see Exhibit A, pages 4-7, 9-14). None of these sheets informs signers that the Respondent-Candidate is seeking the nomination of the Democratic Party for Alderman of the 5<sup>th</sup> Ward of the City of Urbana.
- d. The petition sheet contained in Respondent-Candidate's Nomination Papers that is numbered as "5", fails to comply with the requirement set forth in Section 7-10 that gives information as to the office sought by Respondent-Candidate. (see Exhibit A, page 8). This sheet lists "Urban City Council Ward 5 Alderman" which is not an office for which a candidate will be nominated by the Democratic Party at the Consolidated Primary Election on February 23, 2021.
- e. Each of the signatures on the petition sheets contained in Respondent-Candidate's Nomination Papers that are numbered 1-4 and 6-11, fail to comply with the requirement set forth in Section 7-10 they are qualified primary electors residing in the political division office sought by Respondent-Candidate, as the aforementioned sheets fail to specify which political division the Respondent-Candidate is seeking office in. (see Exhibit A, pages 4-7, 9-14). Each of these

- sheets only lists "Alderman" but fails to specify which Aldermanic District the Respondent-Candidate seeks nomination in.
- 8. Because of the above-listed irregularities in the Nomination Papers, the Nomination Papers are invalid in their entirety.
- 9. Because of the above-listed defects in the Nomination Papers, the Nomination Papers are invalid in their entirety as they are confusing to voters as to the nomination, district, and office sought. See Zapolsky v. Cook County Officers Electoral Board, 296 Ill. App. 3d 731, 734 (1st Dist. 1998).
- 10. Due to the above-listed defects in the Nomination Papers, the Nomination Papers are invalid in their entirety as they denied the persons who signed the petitions information as to the ward the Respondent-Candidate was seeking to represent. The purpose of the nominating petitions signed by voters is to expand the informed participation of members of the respective parties in their primary election and placing the Respondent-Candidate on the ballot despite failing to inform voters of where she was actually running frustrates the rights of voters to make a meaningful choice as to their options in the Consolidated Primary Election. See Salgado v. Marquez, 356 Ill. App. 3d 1072, 1077 (2nd Dist. 2005).
- 11. The requirements set forth in Section 7-10 are mandatory, therefore the Respondent-Candidate's petition sheets must be deemed invalid and stricken for the aforementioned failures to comply with Section 7-10.
- 12. As the Respondent-Candidate's petition sheets must be deemed invalid and stricken for the aforementioned failures to comply with Section 7-10, the Respondent-Candidate has failed to comply with Section 7-10 and the Respondent-Candidate's name must not be printed upon the primary ballot for the nomination of the Democratic Party for the office

of Alderman of the 5<sup>th</sup> Ward of the City of Urbana Illinois in the Consolidated Primary Election on February 23, 2021.

WHEREFORE, the Objector requests a hearing on the objections set forth herein, and examination by the aforesaid Duly Constituted Electoral Board for the Hearing and Passing Upon of Objections to the Nomination Papers of Candidates for Nomination to the Office of Alderman of the 5<sup>th</sup> Ward of the City of Urbana, Illinois; a ruling that the Nomination Papers are insufficient in law and fact, and a ruling that the name of Meghan McDonald shall not appear and be not printed on the ballot for nomination by the Democratic Party to the office of Alderman of the 5<sup>th</sup> Ward of the City of Urbana, Illinois, to be voted for at the Consolidated Primary Election to be held on February 23, 2021.
